

Providing safe working conditions and educating employees on safe working habits can help prevent accidents, save lives, help to avoid citations by the Occupational Safety and Health Administration, and lower your workers' compensation costs. Louisiana AGC's Safety Committee provides multiple services to help members improve safety on their jobsites.

The LAGC Safety Committee members meet monthly to discuss OSHA Rules and Regulations. Some services offered by our Safety Committee include:

- Review of your safety program
- Inspecting jobsites for potential OSHA violations and unsafe acts or conditions
- Periodic Training on OSHA standards
- Updates on OSHA regulations & other legislative changes
- Telephone consultation and safety meetings

Latest: An alliance signed on Oct. 29, 2015 renewed a commitment to material and knowledge access that aims to promote understanding of the workplace safety and health rights and responsibilities of workers and employers, including industrial and construction general contractors, subcontractors, suppliers and service firms throughout Louisiana. Focus continues on reducing and preventing exposure to falls from elevated work surfaces, electrocution, heat illness, exposure to hazardous chemicals, struck -by and caught-in or -between hazards. Throughout the duration of the agreement, OSHA will provide safety and health information in English and Spanish to construction and general industry workers.

The OJT Program was developed in conformity with FHWA requirements. The LADOTD seeks to achieve the goal to provide training to individuals, including minorities, women, disadvantaged individuals and protected veterans. ## BULLDOZER OPERATOR DOT NO. 850.683-010

#### Approximate training time: 18 Weeks or 720 Hours

#### JOB DESCRIPTION

Operates a large tractor with a concave steel blade or push block mounted in front of the chassis. Equipment is used to level, distribute and push earth. This work is subject to strict inspection and must conform closely to specifications. This equipment may be used as a pusher to load earth carrying equipment. At times a ripper attachment is used for ripping the earth prior to loading the scraper. Regulates height to blade or push block from ground. May oil, grease, or otherwise service and make necessary adjustments to equipment as needed. Performs other related duties.

#### WAGE STRUCTURE

Trainee will be paid the trainee wages specified in the construction contract. If no trainee wages are specified in the construction contract, minimum trainee wages will be as follows (but not less than the current minimum wage):

- 1. The Beginning of the Training Period: Sixty percent (60%) of the skilled wage rate specified in the contract of this classification.
- 2. After Completion of One Half (<sup>1</sup>/<sub>2</sub>) of the Training Period: Seventy-five percent (75%) of the skilled wage rate specified in the contract for this classification.
- **3.** After Completion of Three Fourths (<sup>3</sup>/<sub>4</sub>) of the Training Period: Ninety percent (90%) of the skilled wage rate specified in the contract for this classification.
- 4. On Completion of the Training Period: One hundred percent (100%) of the skilled wage rate specified in the contract for this classification.

OSHA Standards: Protection on the Job..... OSHA standards are rules that describe the methods that employers must use to protect their employees from hazards. There are OSHA standards for <u>Construction</u> work, <u>Agriculture</u>, <u>Maritime</u> operations, and <u>General Industry</u>, which are the standards that apply to most worksites. These standards limit the amount of hazardous chemicals workers can be exposed to, require the use of certain safe practices and equipment, and require employers to monitor hazards and keep records of workplace injuries and illnesses. Examples of OSHA standards include requirements to: provide fall protection, prevent trenching cave ins, prevent some infectious diseases, assure that workers safely enter confined spaces, provide respirators or other safety equipment, and provide training for certain dangerous jobs.

Employers must also comply with the <u>General Duty Clause</u> of the OSH Act, which requires employers to keep their workplace free of serious recognized hazards. This clause is generally cited when no OSHA standard applies to the hazard.

#### **Employer Responsibilities**

Employers have the responsibility to provide a safe workplace. **Employers MUST** provide their employees with a workplace that does not have serious hazards and follow all relevant OSHA safety and health standards. Employers must find and correct safety and health problems. OSHA further requires employers to try to eliminate or reduce hazards first by making changes in working conditions rather than just relying on masks, gloves, ear plugs or other types of personal protective equipment (PPE). Switching to safer chemicals, enclosing processes to trap harmful fumes, or using ventilation systems to clean the air are examples of effective ways to get rid of or minimize risks.

Employers **MUST** also:

- Inform employees about hazards through training, labels, alarms, color-coded systems, <u>chemical information sheets</u> and other methods.
- Keep accurate records of work-related <u>injuries and illnesses</u>.
- Perform tests in the workplace, such as air sampling required by some OSHA standards.
- Provide hearing exams or other medical tests required by OSHA standards.
- Post OSHA citations, injury and illness data, and the <u>OSHA poster</u> in the workplace where workers will see them.
- Notify OSHA within 8 hours of a workplace incident in which there is a death or when three or more workers go to a hospital.

Not discriminate or retaliate against a worker for using their rights under the law.
