**TranSET New Orleans-Baton Rouge Rail Links-Findings**

The technical phase is now wrapped up. The existing conditions, active transportation, and transit networks surrounding it are under developed in most places. Last summer, we launched an online survey with choice experiment. The survey results are attached.
