Research Project Update

- Highlight project outcomes on DOTD's Complete Streets website to encourage Complete Streets policy implementation statewide

EBRCSA Committee: Creating a definition matrix to perhaps change statutes to more consistent language.

Lynn Maloney-Mújica suggests to contact Dan Jatres to aid in ramping up policy to access funding (creating a more intentional policy) based on equity and vulnerable users.
