## **Call to Order**

Alan Krouse called the meeting to order, and it was determined that a quorum was present.

## **Approve Previous Minutes**

Alan entertained a motion to approve the minutes. It was so moved by Cheri Soileau and seconded by Joy Sims. The minutes were approved.

# **General Discussion**

## New Orleans Complete Streets Coalition Updates/Initiatives

Nellie Catzen provided an update on the Better Bus Stops campaign, funded by a \$100,000 grant from the Greater New Orleans Foundation. The project aims to improve transit stop infrastructure, with a goal of adding shelters to 80-90% of stops. Challenges include setback requirements on state highways, leading to efforts to create standardized exceptions and urban standards. A federal funding proposal to construct about 200 shelters is being prepared for submission in early 2025.

Laura Harris discussed Bike Easy's collaboration with the New Orleans Coalition to enhance intersection visibility through daylighting, focusing on the 7th Ward and other neighborhoods. Efforts include identifying high-risk intersections, preventing illegal parking, and advocating for Complete Streets improvements on the St. Claude Corridor, where bike lanes are frequently blocked by parked cars. Discussions included integrating design elements like trees and fencing to improve pedestrian safety and aesthetics, while addressing concerns such as illegal parking and pedestrian crossings. They aim to work with the LA DOTD to address these issues.

The Safe Streets for All Action Plan was also highlighted, with Tool Design as the contractor. The plan is set to be completed by summer 2025 to apply for construction funding in 2026.
