The department intends to contract with a private firm to solicit sponsors for advertisement and sponsorships on department assets and rights-of-way. It is anticipated that the private firm will retain 25 to 30 percent of all revenues collected and the department will receive the remainder. Any funds received from sponsorships will be used only for highway purposes. The amount of revenue the department is expected to generate is based upon estimates contained in a report entitled Governmental Efficiencies Management Support (GEMS) Transportation and Development Assessment / Plan, which was prepared by Alvarez & Marsal Public Sector Services, LLC.
