**RE: DBE Goal Setting
Fiscal Year 2013-2015**

Dear Mr. Patrick:

The Louisiana Department of Transportation has established a goal of 0.0126% for the Federal Transit Administration (FTA) for the FY 2013-FY2015. This goal encompasses DBE utilization as prime contractors and consultants, as well as subcontractors and subconsultants on FTA funded projects. Also, enclosed is the DBE Goal Setting Methodology (Exhibit A) explanation report for your information, review, and approval.

Of the 1,299 firms in our database, 1,158 are non-DBE contractors and 141 are DBE contractors. The database used to determine the base goals draws information from the Department's ready, willing, and able list. This list includes all firms bidding as prime contractors, which are found on the Department's LaGov system. This system includes the names of contractors, suppliers, and consultants which have been paid for services to the Department. It also includes information submitted by prime contractors on firms which have quoted prices for sub contractual work. We believe that this shows diligence in identifying all ready, willing, and able firms.

In determining the DBE goal, DOTD took into consideration all prime contracts and subcontractors performed by DBE contractors which were obtained without the benefit of goal requirements. Analysis of the past participation by our DBE community confirms that an overall DBE goal in excess of 0.026% would not be reasonable target in Louisiana. A full explanation and calculation are included in Exhibit B and C.

The Department is requesting FTA approval of the Louisiana DOTD's DBE Goal and process for Fiscal Years 2013-2015. If you have any questions, or need additional information, please contact me or my Program Supervisor, Harold Beck at (225) 379-3060 or email harold.beck@la.gov.

This document explains the methodology used by our department to establish our fiscal year 2013-15 DBE goal.

GOAL SETTING METHODOLOGY 49 CFR PART 26.45

The federal regulations require recipients to set overall goals based on demonstrative evidence of availability of ready, willing and able DBEs relative to all businesses ready, willing and able to participate on DOT assisted contracts.

A. Step 1 Base Figure Determination 26.45(c)

- 1. The Louisiana DOTD has elected to use a ready, willing and able bidders list, to determine our base figure. In order to capture this information on successful and unsuccessful bidders and quote providers that have participated on DOTD contracts, during a two year period of 2011 – 2012, the firms are tracked by an internal data base system. Ready, willing and able firms as described above are included as Exhibit A.**
- 2. Of the 1299 firms on our database, 1184 are non-DBE contractors and 115 are DBE contractors. Utilizing this information, we arrived at a base figure of 0%, included as Exhibit B.**

B. Step 2 Adjustment Factors 26.45(d)

- 1. We determined our past accomplishment based on the median of awards for the last five consecutive years. The figures are as follows: 2008 – 0%; 2009 – 0%; 2010 – 0%; 2011 – 0%; and 2012 – 2%. Thus, the median of the last five years is 0%. Using this mean and our base figure (0%) resulted in a goal of 0%. The analysis of past participation results are shown in Exhibit C.**
- 2. We are not aware of recent disparity studies; therefore, this was not included as a part of the adjustment factor.**

C. Public Participation 26.45 (g)

- 1. Public consultation forums were where all interested stakeholders, including our DBE firms; the contracting community, AGC, minority and women organizations, and other interested parties were invited. These two public consultation forums were held on April 23rd in Shreveport and the second on April 25th in the auditorium of the DOTD headquarters building in Baton Rouge. Information relative to our public participation process is in Exhibit D.**

- 2. On May 23, 2013, our DBE goal and contact information for viewing our methodology was posted on our department's website and in the lobby our headquarters building. We have also published it for public comment in newspapers around the state including the following: The Baton Rouge Advocate, the Shreveport Times, The Times Picayune, the Monroe New Star, the Lake Charles American Press, the New Orleans Daily Journal, and the Alexandria Town Talk, which are shown in Exhibit E**




